Stay Over Visitation

Preliminary arrivals for January to December 2015 show an 8.6% decline in stay over visitation. 74,474 stay over visitor arrivals were recorded compared to 81,511 in 2014. The passage of Tropical Storm Erika at the end of August had a ripple effect on arrivals for the last four months of 2015, to include loss of key hotel stock, most notable the 35 rooms at Jungle Bay Resort and Spa, as well as the cancellation of the 19th World Creole Music Festival.

The Third Quarter – Tropical Storm Erika

Note: Due to data loss, arrivals to Douglas Charles Airport for August 2015 were estimated, Revision to 3rd Quarter Arrivals expected. Arrivals during July 2015 grew 0.6% to 9,252 and were the only positive growth registered during the 3rd quarter (July – September). This growth was primarily attributable to increased arrivals from European source markets, with registered overall growth of 17.7% for the month. Estimated arrivals for August registered a 3.9% decline to 7,675, 314 arrivals less than 2014. This decline could possibly be directly connected to the passage of Tropical Storm Erika. Historically, the average non-student arrivals for August 27 to 31, averaged at approximately 660 stay over visitors, reaching 728 in 2014; student arrivals over the five day period are usually between 300 and 360 students.

With Douglas-Charles Airport closed through September 18th, achieving stay over arrivals for September 2015 of 3,763 was still on par with the 10 year average of 3,800. These arrivals represented a 10.6% decline from 2014's 4,183. Students (1,164) dominated the September stay over arrivals, representing 30.9% of the month's total.

The Fourth Quarter

Stay over arrivals for October proved to be the hardest hit post-Erika. Only, 4,611 stay over arrivals were recorded for the month, a 46.3% decline from 2014's 8,584. In previous years, arrivals attributed to the World Creole Music Festival, have accounted for 61% of total October arrivals, these WCMF arrivals typically range between 4,700 and 5,500 annually.

The post storm fallout continued through the end of the year, Preliminary November arrivals (3,890) registered below 4,000 for the first time since 2010's 3,930, representing a 15.8% loss from 2014 (4,618). The 6,377 preliminary arrivals recorded for December 2015, were 18.8% below 2014's 7,853, and this was also the first time the month registered below 7,000 after 2007, when 6,584 arrivals were recorded.

Overall, analysing the arrivals from August 27 through the end of 2015, the total year over year decline was 7,498 stay over arrivals or 28.5% from 2014, with October representing 56.5% of the loss.

Market Performance

The primary shining star for 2015 was the United Kingdom, which still registered a 1.6% growth in arrivals to 4,951.

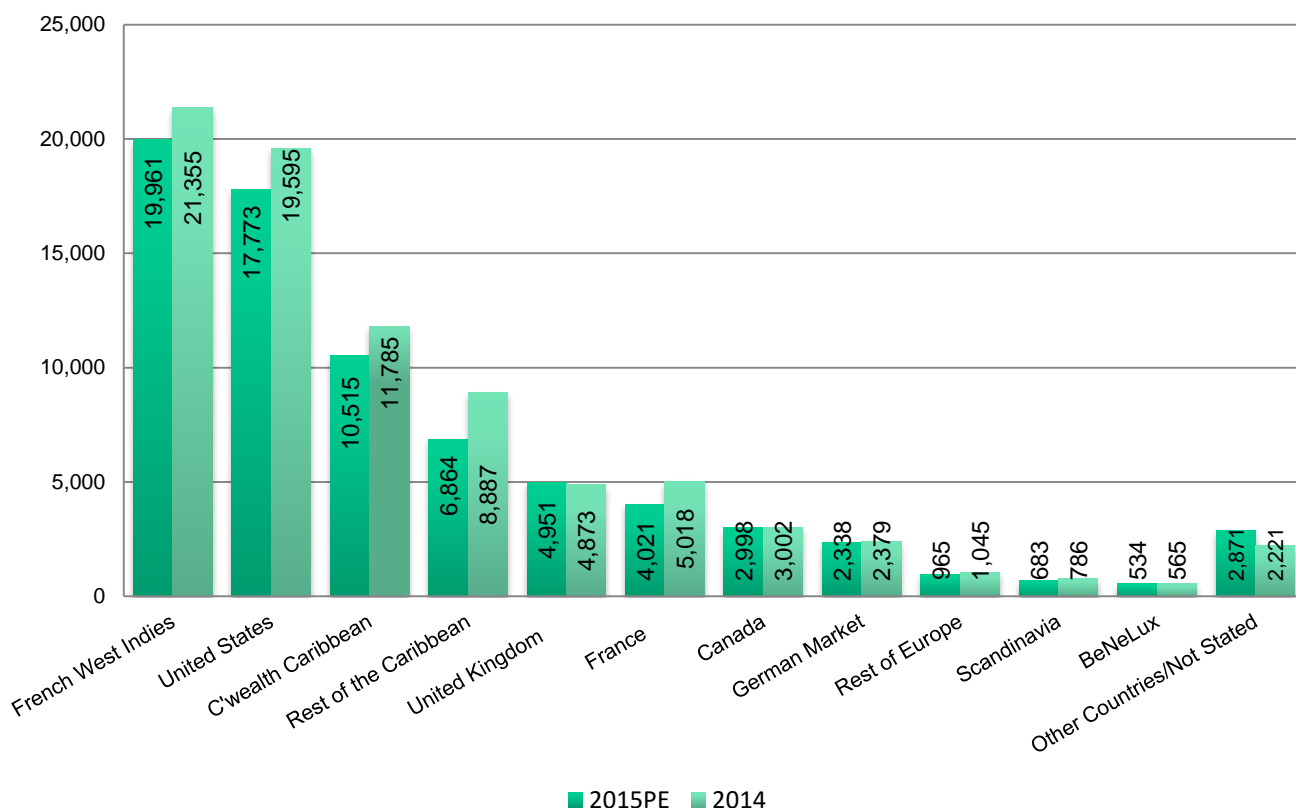


Figure 3: Arrivals by Region

Stay over arrivals from the United States took a sizeable hit, ending 2015 at 17,773; 9.3% or 1,822 less than arrived in 2014. Despite this decline, US Arrivals did represent 23.9% of 2015 stay over arrivals. Student arrivals from the United States (3,635) were 20.4% of total arrivals from the Market. Total non-student arrivals were 14,138, 10.8% less than 2014 (15,853).

Arrivals from Canada were relatively flat in 2015; there was only 0.1% decline from 3,002 in 2014. The 2,998 visitor arrivals were recorded from Canada represented 4% of total arrivals. Students, at 439, accounted for 14.6% of total Canadian visitation, similar to 2014 when 440 student arrivals were recorded from the market. Non-student Canadian arrivals were 2,559 in 2015.

The other European source markets did not perform as well as the United Kingdom. Arrivals from France fell 19.9% from the 2014 record breaking 5,018 to 4,021 in 2015. The German Speaking Markets registered a 1.7% decline to 2,338, which was primarily due to a 4.1% loss of arrivals from Germany. Arrivals from Germany closed 2015 at 1,580; both Switzerland (580) and Austria (178) recorded marginal growth during the year. Along with the United Kingdom, arrivals from France and Germany accounted for 78.2% (10,552) of total European stay over visitation to Dominica in 2015

Arrivals from the French West Indies performed above 2014 through September 2015. At the nine month mark, total stay over arrivals were at 16,263, 5.8% above 2014 (15,377). However, arrivals took a 38.1% or 2,280 arrival hit during the fourth quarter, closing 2015 at 19,961, 6.5% behind 2014's 21,335.

Visitation from the other English Speaking CARICOM countries registered an overall decline of 10.8% to 10,515. Arrivals from St. Maarten/St. Martin (1,839) and the US Territories (3,417) – US Virgin Islands and Puerto Rico – also had year over year loss of 23.8% and 3.9%, respectively, from 2014. This cross section of the Caribbean represented 21.2% of total arrivals in 2015 and had a total loss of 1,990 or 11.2%.

Where do they stay & Why do they come?

For 2015, we saw an overall decline in year Hotel Occupancy rate. Through December, hotel occupancy was 50.6%, a 2.3% decline compared to 51.8% in 2014. It is important to note that between September and December there was year over year growth in Occupancy of 21.3%; this can however be partially attributed to loss of room stock following Tropical Storm Erika. There was also a decline in the number of visitors indicating they would be staying in hotels and similar accommodations while on island. 27,423 or 36.8% of stay over visitors indicated their accommodation of choice as Hotel, Guest House, Lodge, Bed & Breakfast, Inn, Apartment, or Cottage, representing a 10.8% decline from 2014 (30,757). Visitors staying private homes also decreased 9% to 40,996 for the year.

Twenty-four percent (17,710) of stay over arrivals in 2015 were of visiting Dominican Nationals (born in Dominica and/or Dominica passport holders but living abroad), representing a 7.1% decline from 2014 (19,068). This loss was predominately during October - 30.4% decline to 1,734, December – 26.4% decline to 1,886, and August a 22.9% decline to 1,274.

Arrivals for study during 2015 were 4,663 or 6.3% of total visitation, a 1.7% increase from 2014. The primary markets in which students reside were the United States – 3,635 (78.0%), Canada – 439 (9.4%), and Nigeria – 368 (7.9%). Over the last two years, there has been steady growth in arrivals from Nigeria, primarily students and their families, total Nigerian arrivals for 2015 were 440 a 22.9% increase over 2014 (358).

Business related travel to Dominica (*including meetings and conventions*) was 8,114 and accounted for 10.9% of stay over arrivals. There was 4.6% decrease in business arrivals. Due to Tropical Storm Erika, a new disaggregation of travellers was observed, arrivals for “relief”; 248 arrivals were recorded between September and December of persons specifically stating their primary reason for visiting Dominica was the post-storm relief efforts.

Arrivals for “vacation” decreased 6.5% to 48,835 in 2015; however this is still the primary reason for visiting the island and represented 65.6% of total arrivals for the year. There were 9,746 arrivals of persons visiting friends and relatives, 3.5% increase from 2014 (9,418).

Same Day Visitation/Excursionists

1,534 same day visitors arrived in Dominica in 2015, a 30.1% decline from 2014 (2,195). 970 or 63.2% of these visitors arrived for leisure, while 315 or 20.5% were in-transit passengers. 12.1% (186) were arrivals for business and meetings.

Arrivals from Guadeloupe (492) and Martinique (449) collectively represented 61.3% of the same day arrivals, and were 31.7% less than in 2014. 895 (58.3%) of same day arrivals were on the ferry.

Access

With the damage sustained to Douglas-Charles Airport from the passage of Tropical Storm Erika in August 2015, Dominica's access was further challenged. Douglas-Charles Airport remained closed until September 18, 2015. While some carriers transferred service to Canefield Airport and LIAT and Seaborne attempted to facilitate access with flights to Guadeloupe and Martinique for onward connection via the ferry, we still realized a 5.8% decline in total passenger arrivals to 107,553. This loss was all from decreased visitor arrivals as there was 3.7% increase in resident arrivals¹.

Ferry

Total passenger arrivals on L'Express des Iles/JEANS increased 3.4% to 41,665 for 2015. However, there was a 1.6% decrease in stay over visitors using the service to 29,395 in 2015, from 29,861.

Guadeloupe (13,224), Martinique (5,721), France (3,152), Germany (1,041), and St. Lucia (845) are the usual top five countries of residence for stay over visitors arriving to Dominica by ferry. In 2015, primarily as a post-Erika effect, 1,934 United States stay over visitor arrivals were by ferry, a 266.3% increase from only 528 in 2014. These arrivals were primarily concentrated in September with arrivals for Medical School students, family, and staff. 1,110 or 57.4% of the total US ferry arrivals were in September 2015.

With the introduction of low cost carrier Norwegian Airlines' flights between three US gateway cities and Guadeloupe and Martinique in December, it is possible that visitors embraced the access opportunity. There was a small increase in US arrivals by Ferry in December 2015 to 187, from only 38 in the previous year. There will also be Air Antilles proposed Fort-de-France/Douglas-Charles flight twice weekly, as well as the continued WINAIR (Air Antilles) Point-a-Pitre/Douglas-Charles flight four times weekly, as additional options for US travellers to connect to Dominica from the French West Indies taking advantage of Norwegian's service.

¹ *Resident Arrivals differ from Dominican Nationals residing abroad; Residents are the persons with primary permanent/long term domicile in Dominica who may be National or Non-National; Dominican Nationals (or Visiting Nationals) are Dominican by birth or traveling on a Dominican passport but Dominica is not the primary of domicile*

Air

Post-Erika closure and reduce flights contributed to the 14.4% decline in arrivals to Douglas-Charles Airport for 2015. More than 10,000 less passengers arrived at Douglas-Charles in 2015, 7,840 of this loss was in stay over visitation.

LIAT remained the majority share carrier in 2015 and brought 43,006 of passenger arrivals, 19.0% decline; 28,518 stay over visitor arrivals for the year were through LIAT's services. There was 8.5% decline in overall passengers and 7.8% decline in stay over visitors arriving on Seaborne in 2015 to 8,833 and 7,215 passengers and stay over visitors, respectively. Possibly it was the addition of service into Canefield post-Erika that contributed to the 40.1% increase in passenger arrivals on WINAIR in 2015. 5,027 of the 7,284 WINAIR passenger arrivals were for stay over visits, a 34.3% increase. Hummingbird Air contributed to 1,977 passenger arrivals in 2015 before suspending passenger service, of which 1,415 were stay over. Overall, 3,686 passengers arrived into Canefield Airport in 2015, 154% increase from 2014. Of these passengers, 63.9% or 2,354 were stay over arrivals. WINAIR announced regular three times weekly service between St. Maarten and Canefield starting January 2016, which should positively benefit overall access to Dominica.

Cruise

In 2015, Dominica received 186 cruise calls which were 13 less than received in 2014, a 6.5% decline. These vessels brought 279,474 passengers, a 2.5% decrease from 2014 (286,573).

Eight vessels made inaugural calls to Dominica during 2015, including Carnival Triumph and Carnival Sunshine, MSC's Orchestra and Musica, and TIU's Mein Schiff 3.

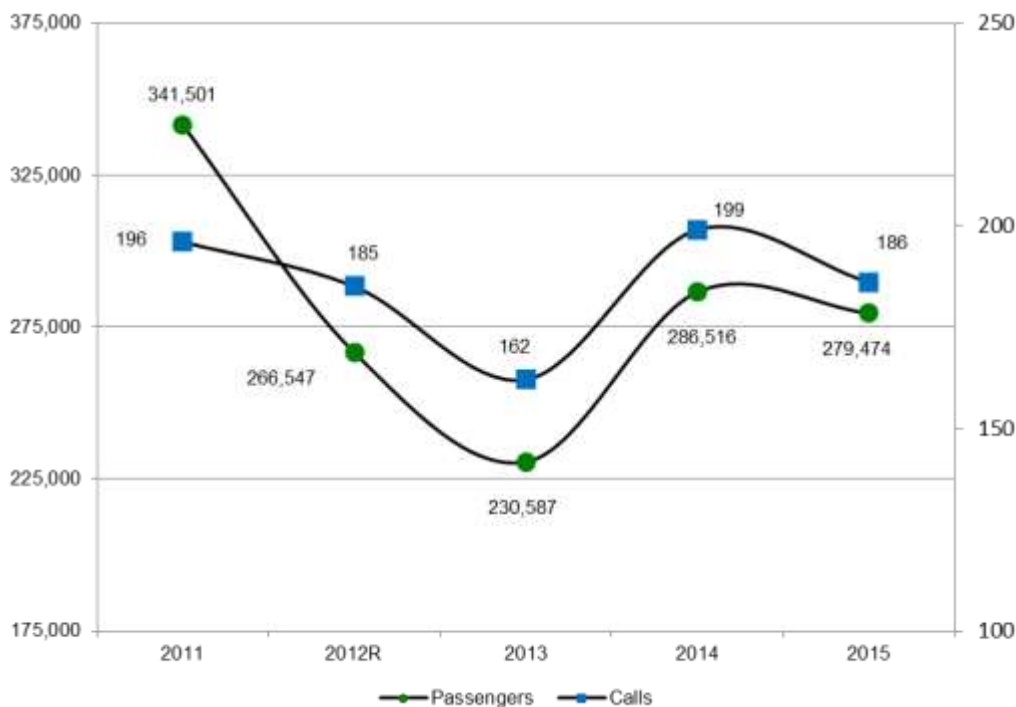


Figure 6: Trend in Cruise Arrivals 2011 - 2015

Yacht

2,971 vessels cleared Customs in Dominica during 2015; this was 1.8% increase from 2014 when 2,918 vessels cleared. The majority of the growth recorded was in vessels clearing in Roseau/South, which has a preliminary count of 968 vessels, representing a 32.8% growth over 2014. There was an 8.5% decline vessels clearing at Portsmouth in 2015 at 2,003 vessels.

The vessels brought 12,175 passengers and crew into Dominica representing a 0.3% increase from 2014 (12,134). 8,243 arrived at Portsmouth and 3,932 arrived at Roseau. Approximately seventy percent of yachts arrive in Dominica during January to May, and in 2015, 2092 vessels carrying 8,695 of the total passengers and crew received for the year.

Conclusion

Dominica's Tourism Sector did face its challenges in 2015; however through increasingly positive media coverage across the key target markets and new campaigns showcasing the unique features of the destination a positive rebound is possible in 2016.

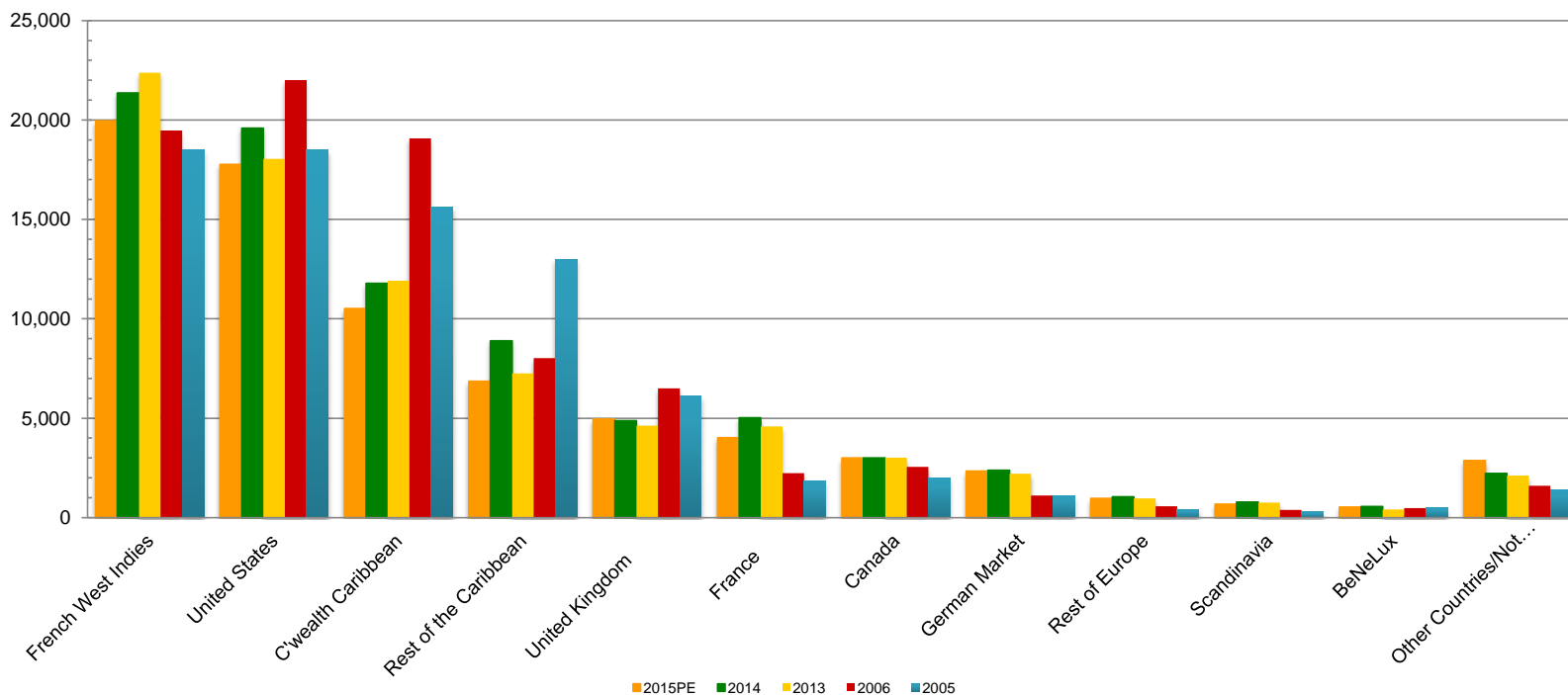
